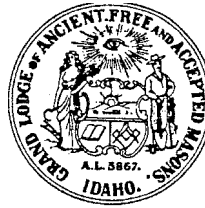

## GRAND LODGE OF IDAHO

### FORMAT FOR PROPOSED LEGISLATIVE CHANGES

Proposed resolutions must be received by the Grand Secretary by February 15 for distribution to the Jurisprudence Committee.

#### 8. CURRENT WORDING OF SECTION TO BE CHANGED:

1. **Preparation, Proofing and Filing.** The entire section or parts proposed for change shall be prepared in triplicate in the desired written form, signed by no less than three (3) members of the Grand Lodge or by the Worshipful Master and Secretary of a chartered Lodge attested under seal, and filed with the Grand Secretary on or before the fifteenth day of April next preceding the Annual Communication of the Grand Lodge.

#### 9. CURRENT WORDING WITH DELETIONS: (Lined out or underlined)

1. **Preparation, Proofing and Filing.** The entire section or parts proposed for change shall be prepared in triplicate in the desired written form, signed by no less than three (3) members of the Grand Lodge or by the Worshipful Master and Secretary of a chartered Lodge attested under seal, and filed with the Grand Secretary on or before the fifteenth day of April next preceding the Annual Communication of the Grand Lodge.

#### 10. CURRENT WORDING WITH ADDITIONS: (*Use Italics to highlight additions*)

1. **Preparation, Proofing and Filing.** The entire section or parts proposed for change shall be prepared in the desired written form, signed by no less than three (3) members of the Grand Lodge or by the Worshipful Master and Secretary of a chartered Lodge attested under seal, and filed with the Grand Secretary on or before the fifteenth day of *February, which shall be proofed for conflicts in Idaho Masonic Code and Digest by the Standing Committee of Jurisprudence on or before the 15th day of March, which shall be returned to authors with*

*all conflicts of our Code so stated, which shall then be filed with the Grand Secretary on or before the 15th day of April next preceding the Annual Communication of the Grand Lodge.*

11. ENTIRE PARAGRAPH AS INTENDED TO READ IN THE CODE AND DIGEST:

(Not necessary if entire paragraph is new and has been stated in 10, above)

1. **Preparation, Proofing and Filing.** The entire section or parts proposed for change shall be prepared in the desired written form, signed by no less than three (3) members of the Grand Lodge or by the Worshipful Master and Secretary of a chartered Lodge attested under seal, and filed with the Grand Secretary on or before the fifteenth day of February, which shall be proofed for conflicts in Idaho Masonic Code and Digest by the Standing Committee of Jurisprudence on or before the 15th day of March, which shall be returned to authors with all conflicts of our Code so stated, which shall then be filed with the Grand Secretary on or before the 15th day of April next preceding the Annual Communication of the Grand Lodge.

12. RATIONALE (Why the author thinks the proposed change is needed):

This change is necessary to provide feedback to resolution authors prior to arriving at Grand Lodge. When the resolutions are read in the Lodges prior to Grand Lodge they should be in proper form and not in conflict with the existing Code and Digest, this procedure allows for that.

13. Printed NAMES, OFFICE and LODGE NUMBERS of submitting members:

NOTE: Must be signed by no less than three (3) members of the Grand Lodge or by the Worshipful Master and Secretary of a chartered Lodge, attested under seal.

14. SIGNATURES:
